





Subject: Release of funds for making payment through DBT mode into the accounts of students from 1st to 8th class of Government schools entitled for free uniform under RTE Entitlements (Elementary) for the year 2023-24.

Sanction is hereby accorded to the release of funds to the tune of Rs 5087.05 lacs (Rupees fifty crore, eighty seven lakhs and five thousand only) in favour of Chief Education Officers of the UT, approved under AWP&B 2023-24 on account of Free uniforms under RTE Entitlement (Elementary) for class 1st to 8th students enrolled in Government schools. The funds are released as per the breakup given hereunder, for their further release to the Zonal Education Officers under instruction to disburse the funds to Aadhar based accounts of the eligible students or the parents (In case the bank account of students is not available) @ Rs 600/- per eligible students through DBT (Direct Benefit Transfer) mode.

The funds are released subject to the following conditions: -

1. Chief Education Officer shall make allocation to ZEO within 02 days and ZEO will complete the DBT of the amount into accounts of beneficiaries within 07 days, before 30th June 2023.

2. The funds shall be utilized for the purpose it is released.

3. The funds shall be released @ Rs 600/- per eligible student. 4. The parents of the students may be advised to purchase the uniform by adhering to the norms and specifications notified in the Government order No:1383-Edu of

2021 dated 24-08-2021 (copy enclosed) to ensure uniformity and quality. 5. District level committees headed by DEPO and Zonal Level Committees headed by the Zonal Education Officer be formed to monitor the DBT and also ensure that students purchase defined uniforms and attend school in it.

6. The accounts and other record be kept open for audit and inspection.

7. All the eligible students shall be covered and detailed report be furnished before 15th of July 2023.
